NOTICE OF PUBLIC HEARING #2 COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS

Preble County intends to apply to the Ohio Development Services Agency for funding through the competitive Community Development Block Grant (CDBG) Critical Infrastructure Program, a federally funded program administered by the State of Ohio. The County is eligible to receive up to \$300,000 of Critical Infrastructure funding provided the County meets applicable program requirements. On February 12, 2018, the County conducted its first public hearing to inform citizens about the entire FY2018 CDBG Program, and the type of programs available, how funds may be used, what activities are eligible and other important program requirements.

A second public hearing will be held April 9, 2018 at 11:00 A.M. in the County Commission Chambers, located on the 1st Floor of the Preble County Courthouse, 101 East Main Street, Eaton, Ohio, to give citizens an adequate opportunity to review and comment on the County's proposed CDBG Critical Infrastructure application(s) before any are submitted to the Ohio Development Services Agency. A representative(s) of the applicant should be present at this hearing to explain their project and to answer questions relative to their application for FY2018 CDBG Critical Infrastructure funding.
