NOTICE OF PUBLIC HEARING #2 COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS

Preble County intends to apply to the Ohio Development Services Agency for funding through the Community Development Block Grant (CDBG) Small Cities Program, Neighborhood Revitalization Program, and Downtown Revitalization Program, federally funded programs administered by the State of Ohio. The County is eligible to receive approximately \$185,000 of FY2018 CDBG Small Cities funding, up to \$500,000 of CDBG Neighborhood Revitalization funding, and up to \$300,000 of Downtown Revitalization funding, depending on decisions regarding the final Federal budget and provided the County meets applicable program requirements. On February 12, 2018, the County conducted its first public hearing to inform citizens about the entire FY2018 CDBG Program, and the type of programs available, how funds may be used, what activities are eligible and other important program requirements.

A second public hearing will be held March 21, 2018 at 1:30 P.M. in the County Commission Chambers, located on the 1st Floor of the Preble County Courthouse, 101 East Main Street, Eaton, Ohio, to give citizens an adequate opportunity to review and comment on the County's proposed CDBG application before it is submitted to the Ohio Development Services Agency on or before June 15, 2018. A representative(s) of the applicant should be present at this hearing to explain their project and to answer questions relative to their application for FY2018 CDBG funding.
